HOW TO USE THIS DOCUMENT

You'll need this document to do your final choice of courses, please, consider all aspects presented below to avoid possible errors:

- Be sure that the course you are willing to follow is programmed in the semester for which you have been accepted (if you are coming for the whole academic year try to distribute wisely your courses).
- Once you have chosen a course click on the "schedule" link. This will lead you to all the information of the course: the schedule, the language of instruction, the professor, the class, etc. (be sure you have internet access and that pop-up windows are allowed).
- Make sure that the schedules do not clash, we recommend you writing them down. Carefully check the group, the language of instruction and other details of the course you have chosen.
- Be sure to correctly make your final selection of courses considering the schedules (courses must not overlap) and the language of instruction. There will be few chances of making changes in October, given that almost all courses will be already full. Therefore, it is highly important to correctly do your selection during the online registration to courses period in July (First term and Annual students) and in January (second term students).
- The courses marked with two asterisks (**) have a group that is available in English, this does not mean that all the groups offered for this course are in English, you must check which group is available in English.

Courses with the language highlighted in red or missing: The language is yet to be confirmed. This information will be updated over the next few weeks. When viewing the schedule, please consider the following:

- **If the professor's name is not listed, the language has not been updated yet, and the information shown may pertain to the previous academic year.**
- **If the professor's name is listed, it indicates that the language of instruction for the course has been updated for the 2024-2025 academic year.**

The fact that the course names are presented in English, does not indicate the language of instruction of the course, you have to click on each course to check the language of instruction.

Information about the language course indications: Each course may have several groups. The language indicated in the column "Idioma-Language" indicates the language of instruction in which the different groups of one course are offered: **ES= SPANISH (Castellà); EN= ENGLISH (Anglès); CAT= CATALAN (Català)**

WHAT TO TAKE INTO ACCOUNT WHEN SELECTING THE COURSES

Make sure that you meet the requirements or have sufficient knowledge to take the courses you choose. For example, do not choose Microeconomics III if you have never taken a course about Microeconomics.

Don't enroll the same courses with different difficulty levels in the same semester. If you do so, you will only be enrolled to the course with a lesser level. For example, if you choose Macroeconomics IV and Macroeconomics III for the first semester, we will only enroll you to Macroeconomics III.

The Faculty of economics and Business of the UB has a high mathematic level; we recommend that you DO NOT choose those courses with a strong mathematic component (for instance, advanced levels of Microeconomics and Macroeconomics, Econometrics, Industrial Organization).



Please be aware that the following subjects are the same (or very similar) but have different names since they are offered in different degrees. Since they have the same content, you are only allowed to choose ONE of the two when selecting courses. The subjects are:

- Principles of Marketing (Business) - International Commercial Management (International Business)
- Tax System I (ECO) – Principles of Taxation (Business)
- Tax System II (ECO) – Business Taxation (Business)
- Analytic Accounting (Business) – Management Accounting (International Business)
- Corporate Finance (Business) - Finance II (international Business)

Once you have entered in the “Schedule” link, you have to consider that groups **Z and Y** are **not offered** to exchange students as these groups are for students who repeat the course or do a double degree.

The semester students are allowed to choose MAXIMUM 5 courses in the online enrolment, which will provide them 30 ECTS credits.

The annual students are allowed to choose MAXIMUM 10 courses in the online enrolment, which will provide them 60 ECTS credits.

Although it is not recommended, if the student needs to enroll up to 6 courses per semester, this option will be evaluated in the modification period that will take place after the beginning of the semester.
