Part B. CV SUMMARY

CV summary - I graduated in Philosophy at the University of Barcelona (Extraordinary Prize, 2017), I did the Master's degree in Theoretical and Practical Philosophy at the National University of Distance Education, UNED, (Honorary Diploma, 2019) and I obtained the doctorate cum laude at the University of Barcelona. I am currently a university professor of ethics and social thought at the Open University of Catalonia (UOC) and at the Sarriá Chemical Institute of the Ramon Llull University respectively. In July 2023 I defended a thesis on a burning challenge of contemporary ethical-political thought: the difficulty of reconciling our vulnerability with responsibility for the suffering of others. This research sought to think about human agency beyond the obsolete figure of the autonomous subject, reflecting on subjects such as solidarity, interdependence and care, among others. I focused the thesis on the works of Emmanuel Levinas and Judith Butler, as well as the dialogue – real and hypothetical – between them. The research has been possible thanks to a four-year predoctoral contract for the Training of University Personnel (FPU), an aid granted by the Ministry of Education and under the direction of Josep Maria Esquirol. Likewise, it has been able to be enriched thanks to the support of the French Embassy and the Diálogo Association through its program for excellence and its Avenir grants, which financed a stay at the Paris VIII University, Vincennes - Saint-Denis at the end of 2022. In this way, the exchange has been possible with relevant intellectuals of contemporary ethical-political thought and experts in the authors that concerned me. In parallel, I have been able to continue exploring the issue of vulnerability and its ethical implications and sharing the fruits of this study at different conferences in Catalonia, Spain and South America. Likewise, I have combined research with teaching: in addition to participating in the subjects of Political





Philosophy and Philosophical Problems at the university where I was pursuing my doctorate, since 2020 I have taught different humanistic subjects (philosophical anthropology, ethics...) at the Campus La Salle, the EUSS and the Sarriá Chemical Institute of the Ramon Llull University and the UOC.On the other hand, since the end of 2023, I have participated in two research contracts together with Dr. Begoña Román. In one of them we are developing the ethical code of the International Association of Educating Cities through a participatory process that concerns more than 500 municipalities in 35 countries. The other project consists of the study and development of indicators for good governance, public ethics and public integrity for Ivàlua, the Institute for the Evaluation of Public Policies of Catalonia. Finally, outside and inside the academy I have maintained a strong interest in Eastern thought and its elaborate philosophical tradition, which has taken shape in various ways. For example, I was lucky enough to research the Indian philosopher Nagarjuna under the tutelage of Dr. Piedad Yuste, which culminated in a master's thesis. Also with her, I published a chapter on Buddhism in a book dedicated to the philosophies of India, China and Japan. Since 2018 I have been teaching introductory courses on the theory and practice of Buddhism, and recently, together with a scholar of this tradition, we have started a project to make space for Buddhist studies in the Spanish academic reality through a scholarship from the Khyentse Foundation. Finally, since 2015 I have been co-founder and pedagogical coordinator of the Casa Virupa retreat and meditation center.
