1. Activities promoted by the TransJus Research Institute

Therefore, as of June, TransJus publications appear in the most important search engines of the web and the global impact on the academic community can be evaluated more quickly and easily.

3. Activities of the Board of Directors

During the academic year 2017-2018, two meetings of the TransJus board of directors were held (these can be consulted in the minutes section of the TransJus website). The main topics dealt with in the meetings of the Board of Directors were mainly:

- It was decided to go ahead with the purchase of books linked to the areas of research, both transdisciplinary and of an international nature, at the request of members of the institute,

and to make them available to all members of TransJus. The second purchase has already taken place, which was handed over for safekeeping to the library fund, where TransJus researchers, under a priority regime, and all those interested in the Faculty can access it. The library space dedicated to the TransJus currently has twenty-three books, thirteen of which were purchased. Out of the other ten books, eight have been given by professors of foreign universities and two, being the books published by the TransJus, were given by the same Institute.

- As part of TransJus' work on the preparation of a human-based business model with the World Bank, we proceeded to publish the research activity that Dr. Andrés began during her stay in Washington. She will be proposed to publish her results with TransJus and cover the translation costs generated by the double version of the publication in English and Spanish. The Spanish publication, already mentioned, is available in the publications section of the TransJus website. Dr. Marta Ortega's request regarding the invitation of Dr. Don De Amicis was accepted, in accordance with the call for grants to invite speakers to the Law Faculty then in force. The details of the event in which Dr. De Amicis participated have been mentioned above.
- Three Newsletters were launched and, in accordance with the decision taken by the Board of Directors, were included in a specific section of the the TransJus website: <http://www.ub.edu/instituttransjus/newsletters%20ENG.html>
- The website was translated into Portuguese, completing its 4 current languages (Catalan, Spanish, English and Portuguese) and was improved significantly. A section was created to register the minutes of the Board of Directors and the legal framework for the operation of the TransJus was included on the home page.
- The report for the 2016-2017 academic year of the TransJus was drafted and published on the website in Catalan, Spanish and English.
- Several new members of TransJus in the category of collaborating members have been accepted: María Teresa Ossio, Manel Calbet and Estrella Montolio.
