Access to the procedure as a PhD student

To start the procedure, we must access the link of *Request for deposit of thesis* that we will find in the doctoral student section of the [catalogue of procedures of the Electronic Office](#).

At the time of access, you will be asked to identify yourself by means of UB authentication. PhD students who enjoy a grant and have a contract at the UB, have a double identification – as PDI and as a student. We will only be able to access with the student ID.

If we are connected with the PDI ID, it will not allow us to access the procedure. It is necessary that we change browsers, and access the Electronic Office again.

Online application for the PhD student

Once we have identified ourselves, we will access the programme in which we are enrolled and we will only be able to access the procedure in which we can submit the application.

ATTENTION!

If we do not have a minimum of two enrolments in the doctoral programme and an active enrolment in the academic year in which the application is submitted, we will not be able to start the process.

If we have any incident in carrying out the procedure, we must contact our enrolment centre.

Below, we can see how to carry out the process of applying for the deposit of the doctoral thesis, explained step by step.
