**Beatriz Añoveros**

PhD in Law from the University of Barcelona (2001). She completed an LLM in European Business Law from the University of Amsterdam in 1994 and was awarded a Master of Studies in Legal Research at the University of Oxford in 1999. She is currently Professor in Private international law at the University of Barcelona and has been a visiting scholar at Penn Law (University of Pennsylvania, USA) and at Boston College (USA). She has also been a visiting lecturer at Bocconi University (Italy), the University of Fribourg (Switzerland) and the Freie Universität Berlin (Germany). She is a frequent public speaker and the author of numerous publications on private international law and consumer protection.

**Miriam Anderson**

Associate Professor of Civil Law at the University of Barcelona (Spain). Her research focuses on housing, securities over land, consumer protection and the law of succession, in the context of European private law. Since 2012, she co-directs the Legal Clinic on Housing and Residential Mediation at her Law School. Currently, she co-leads a research project entitled "The Mortgage Credit Directive under review: Towards a digital, sustainable and inclusive European market" (Grant PID2021-127197NB-I00, funded by MCIN/AEI/10.13.039/50110001103, and "ERDF A way of making Europe").

**Monica Navarro-Michel**

Associate Professor of Civil Law at the University of Barcelona. She obtained her PhD in 2000 (with Honours). Visiting researcher at the University of Manchester (2004) and visiting professor at Nova Southeastern University in Florida (2010), Universidad Autónoma de Chile (2016), KU Leuven (from 2014 to 2017). She has held positions at the Faculty of Law as Vice dean for Research and International Relations. She has published and conducted research on topics related to Tort Law, Family Law, and Medical Law. She is a frequent guest speaker at international events on these topics. Her latest publications deal with product liability and artificial intelligence (in Spanish).

**Núria González Campañá**

Assistant Professor at the Constitutional Law Department of the University of Barcelona. She obtained her DPhil in EU Law at the University of Oxford (UK) under the supervision of Prof. Paul Craig. Her thesis focused on the relationship between EU Law and the secession of sub-national entities within Member States. Previously, she graduated in Law at the University of Barcelona (Spain) and pursued a two-year Master in Law and Diplomacy at the Fletcher School, Tufts University (US). A monograph based on her doctoral dissertation will be published in 2023 by Oxford University Press. Núria has carried out research stays at McGill University (Montreal, Canada) and at the European University Institute (Florence, Italy). Her main research lines are self-determination, secession, EU constitutional law and democratic decay and erosion within liberal democracies.

**Elia Marzal Yetano**

Associate professor of Constitutional Law at the University of Barcelona. Between 2004 and 2022 she was professor of Legal History and Constitutional Law at Esade Law School (Ramon Llull University, Barcelona). She obtained her PhD in comparative constitutional Law at the European University Institute (Florence, Italy) with a thesis on the constitutionalisation of immigration law. She has been visiting researcher at the Centre Marc Bloch (Univ. Humboldt, Berlin) and visiting professor at the Law Center of Georgetown University. Her main research lines are immigration law, the historical formation of political structures, the tension between political entities in the production of norms, the protection of minorities in heterogeneous states and the principle of equality.
